- The Company is considered to be a single segment company engaged in the trading of pharmaceuticals formulation. Consequently, the Company has, in its primary segment, only one reportable business segment. Accordingly, there are no separate reportable segments as required under Ind AS 108
- During the year, the Company has carried out rigorous exercise to identify trade receivables which were outstanding since long and not recoverable, hence the same have been recognised as Bad Debts. ### **Opinion**

We have audited the accompanying statement of quarterly and year to date financial results ("the statement") of **Zenlabs Ethica Limited** ("the Company") for the quarter and year ended 31<sup>st</sup> March 2023, attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) including relevant circulars issued by the Securities and Exchange Board of India ("SEBI") from time to time.

In our opinion and to the best of our information and according to the explanations given to us, the statement:

Our opinion is not qualified in respect of the matters as stated in the Emphasis of Matter paragraph.
